 - b. The eligibility of the supplier is restricted to Indian Suppliers.
 - c. The procuring entity intends to give purchase preference to products/goodsmanufactured by micro, small and medium enterprises.
 - *"Local supplier" means a supplier or service provider whose product or service offered for procurement meets the minimum local content of 50% as prescribed in DIPP Order No.P-45021/2/2017-PP (BE-II) dated 28th May, 2018 or by the competent Ministries/Departments in pursuance of this order.

'Local content' means the amount of value added in India which shall, unless otherwise prescribed by the Nodal Ministry, be the total value of the items procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.

Note:

- 1. Kindly confirm that any material are categorized as hazardous / non-hazardous, Dangerous, Radioactive and restricted / permitted for shipment by Air. Supplier has to provide all the documents, certificate, special permission, licence required for shipment to our authorized freight forwarder. Payment of any charges, if required for obtaining Permission of shipment of any material have to be paid to freight forwarder by the supplier.
- 2. Indian Agent quoting on behalf of foreign principle supplier should submit a certified copy of an agreement /Memorandum of Undertaking (MoU) between both the parties along with their offer.
