CSIR-AMPRI had advertised 05 posts of Junior Secretariat Assistant (Gen/F&A/S&P) advertised vide advertisement no. RECT-03/2021 and 09 posts of Junior Secretariat Assistant (Gen/F&A/S&P) advertised vide advertisement no. RECT-01/2025. The examination process of Typing tests and CBT/Written exam as notified for both advertisements have been completed.

As per provisions of the above Advertisements, all the candidates are required to produce Original Documents uploaded along with online application as well as any other document as may be specified by the CSIR-AMPRI at the time of filling on application, failing which their candidature is likely to be rejected.

The candidates who have obtained cut-off marks [Cutoff 60 marks for SC/ST/OBC/PwD category and 70 for UR category out of 200 marks] in Paper-I were considered for the preparation of Merit list based on the marks obtained by the candidates in Paper-II of the CBT examination.

Based on the number of advertised vacancies i.e. 05 posts of Junior Secretariat Assistant (Gen/F&A/S&P) of RECT-03/2021 and 09 posts of Junior Secretariat Assistant (Gen/F&A/S&P) in RECT-01/2025 and marks obtained by candidates in Paper-II of CBT examination, the following provisional list candidates are being considered for the Document Verification. The provisional list of candidates to be called for DV for advertisement no. RECT-03/2021 is enclosed as Annexure-A and for advertisement no. RECT-01/2025 is enclosed as Annexure-B herewith for information of eligible candidates.

Afternoon Session: 11.00 Hrs,

Evening Session: 14:30 Hrs.

Separate emails for notifying the candidates shall be sent by this office. Candidates are required to inform this office through revert email regarding the date and time of DV for timely and smooth conduct of verification process.

Important Instructions for Candidates:

1. **Mandatory Presence and Documentation:** The candidates must appear for the Document Verification personally along with all the relevant documents in original, mentioned in their original application to the post. The candidates are advised to bring self-attested photocopies of their online application form and all the documents attached therewith.
2. **Biometric Verification:** All candidates will be required to undergo mandatory biometric data verification at the DV venue. The biometric data captured shall be cross-verified with the data recorded during the Typing and CBT examination to confirm the identity of the candidate.
3. **Consequences of Non-Appearance or Discrepancies:** It is mandatory to attend the DV as per the schedule. If a candidate fails to appear for the Document Verification on the assigned date and time, their candidature will be considered cancelled without further notice. Furthermore, if any document is found to be invalid, fraudulent, or if the candidate does not meet the eligibility criteria upon verification, their candidature is liable to be rejected.
4. **No Objection Certificate (NOC):** Applicants currently working in Government Departments, PSUs, or Autonomous Bodies must produce a “No Objection Certificate” (NOC) from their current employer at the time of document verification. Failure to do so will result in the cancellation of their candidature.
5. **No Guarantee of Appointment:** Being called for Document Verification does not confer any right to an appointment. The number of candidates called is more than the notified vacancies, and final selection is subject to successful verification and fulfillment of all eligibility criteria.
