- Service Provider shall be wholly responsible any loss of equipment or instruments, man power deployed by him. Moreover S & T Service Provider shall also be responsible for field unit / collection of samples from the field and report must be submitted within stipulated time frame.
- Service Provider Agency / Consultant should furnish an understanding that the ordered services shall be provided / completed within stipulated given period from the date of receipt of order.
