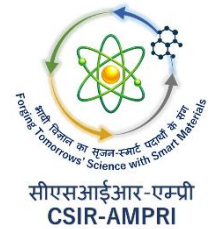

This is to bring to the notice of all applicants who have applied for the following posts against CSIR-AMPRI Advertisement No. RECT-04/2025 that the duly constituted Screening Committee has screened the applications received based on the following Criteria adopted by the Screening Committee to shortlist the candidates for further Recruitment Process:

Core Screening Criteria

- Candidates who meet the Essential Educational qualification(s), Age & Category criteria.
- Candidates Under age (below 18 years) and Over Age (as per advertisement) for each post, as on 04.01.2026 have not been considered. - Clause 3(a) & 2(16).

Reasons for Rejection

In accordance with **Clause 5** of the advertisement, applications that were incomplete or lacked required documentation were summarily rejected. Specific grounds for rejection include:

- Failure to enclose proof of Date of Birth (Clause 2(11)/7(d)), Educational Qualifications (7(f)), or relevant Experience (7(k)).

- Failure to submit a No Objection Certificate (NOC) in the prescribed format (Clause 2(4)/7(l)) or failure to prove "Regular" government employee status for age relaxation claims.
- Discrepancies between the Date of Birth (DOB) entered in the application and the submitted supporting documents.
- Uploaded documents or certificates that were of low quality and could not be verified.
- For post TS-03, only experience gained within a **Government Institute/Sector** was considered valid.

Based on the above mentioned screening criteria adopted by the duly constituted Screening committee, the list of provisionally shortlisted candidates to be called for further recruitment process for the posts of Technical Assistant and Technician (1) is attached as Annexure –I.

The candidates listed in Annexure –II are not recommended and the reason for rejection is indicated against each candidate as per the clause of the advertisement.

Representation(s) if any, regarding eligibility may be sent through e-mail only to recruit.ampri@csir.res.in with a subject "Advt. No. RECT-04/2025 - Representation for the Post code No: __" duly enclosing proof in support of his/her claim may be sent on or before 18.05.2026. The representation (s) received after 18.05.2026 will not be considered under any circumstances.

Representations lodged by telephone and any other mean shall not be considered. Also, representation sent to any other email than aforementioned email, will not be entertained. The decision of the Competent Authority, CSIR-AMPRI on such representations will be final and binding in this regard.

The candidature of the above mentioned 'Shortlisted' candidates for the further recruitment process is provisional and is subject to verification of all relevant original documents in later stage. If at any stage of the recruitment process, it is found that applicant has given wrong information or does not meet the essential qualification and screening criteria adopted by screening committee, the candidature will be liable to be cancelled without any further notice.
