

- 1. Following should invariably be enclosed along with the bid:

 - iii. Price Schedule form

 - vi. Bid-Securing Declaration Form
- 2. The Bid will be rejected if:
 - i. The Bid is unsigned and undated.
 - ii. The Bid validity is shorter than the required period.
 - iii. The tenderer has not agreed to some essential condition(s) incorporated in the tender enquiry.
- 3. <u>Payment: 100% payment on bill basis will be released through RTGS only after satisfactory supply, of the Material at CSIR-AMPRI, Bhopal.</u>
- 3. The suppliers are required to furnish a certificate stating that the rates quoted are reasonable and standard and not higher than those charged to other Government Departments/ Public Sector Undertakings and other CSIR Laboratories. If at a later date, if it is found that similar type of item(s) were sold to other Institutions during the same period at a lesser cost, the difference amount, with penal interest, thereon will be recovered from the supplier. If the vendor have supplied identical or similar item to other CSIR Labs/Instt., the details of such supplies for the preceding three years shall be given together with the prices eventually or finally paid. List of clients in India with supporting proofs for the quoted model must be submitted along with your quotation.
- 4. The tenderer should quote the rates of the items in figures as well as in words. In case of any disputes/ambiguity and the rates quoted in words/figures, the higher value quoted either of the two shall be considered.
- 5. The quotations shall be valid for a minimum period of 90 days from the date of opening of the tender.
- 6. Specific delivery period for supply at CSIR-AMPRI, Bhopal must be indicated. No extension for supply beyond due date will be granted.
- 7. The penalty shall be 0.5% per week towards late delivery & towards delay in installation & commissioning subject to the maximum of 10% of the total value of the Purchase order.
- 8. No request for incorporating Post Tender changes in quoted specifications and correcting typographical error will be considered after opening of submitted tenders. Corrections, erasers, if any, in the quotation must be countersigned and number of corrections/erasers must be indicated specifically.
- 9. Tenders which do not fulfill any or all of the above conditions or incomplete in any respect, are liable for rejection.
- 10. Any difference / dispute arising out of the agreement shall be referred to the Delhi International Arbitration Centre (DIAC), Delhi High Court, New Delhi.
