1. Following should invariably be enclosed along with quotation:
  - (i) Valid GSTN
  - (ii) Company's PAN no.
  - (iii) Manufacturer Authorization Certificate.
2. The Bid will be rejected if:
  - (i) The Bid is unsigned and undated.
  - (ii) The Bid validity is shorter than the required period.
  - (iii) The tenderer has not agreed to some essential condition(s) incorporated in the tender enquiry.
3. The suppliers are required to furnish a certificate stating that the rates quoted are reasonable and standard and not higher than those charged to other Government Departments/ Public Sector Undertakings and other CSIR Laboratories. If at a later date, if it is found that similar type of item(s) were sold to other Institutions during the same period at a lesser cost, the difference amount, with penal interest, thereon will be recovered from the supplier. If the vendor have supplied identical or similar equipment to other CSIR Labs/Instt., the details of such supplies for the preceding three years shall be given together with the prices eventually or finally paid. List of clients in India with supporting proofs for the quoted model must be submitted along with your quotation.
3. The tenderer should quote the rates of the items in figures as well as in words. In case of any disputes/ambiguity and the rates quoted in words/figures, the higher value quoted either of the two shall be considered.
4. The quotations shall be valid for a minimum period of 90 days from the date of opening of the tender.
5. Specific delivery period for supply at CSIR-AMPRI, Bhopal must be indicated. No extension for supply beyond due date will be granted.
6. The penalty shall be 0.5% per week towards late delivery & towards delay in installation & commissioning subject to the maximum of 10% of the total value of the Purchase order.
7. Unloading of material at AMPRI, Bhopal Stores has to be arranged by the firm.
8. No request for incorporating Post Tender changes in quoted specifications and correcting typographical error will be considered after opening of submitted tenders. Corrections, erasers, if any, in the quotation must be countersigned and number of corrections/erasers must be indicated specifically.
9. Tenders which do not fulfill any or all of the above conditions or incomplete in any respect, are liable for rejection.
10. Any difference / dispute arising out of the agreement shall be referred to the Delhi International Arbitration Centre (DIAC), Delhi High Court, New Delhi.
11. Conditional quotations shall not be accepted.
12. All the corrections and alterations made in the quotations must be duly countersigned by the authorized signatory, without which quotation will not be considered.
13. In case of non-fulfillment/non-compliance of the above terms & conditions, your quotation shall be treated as incomplete.
14. Payment: 100% payment on bill basis will be made through RTGS/PFMS only after satisfactory supply, of the Material.
15. In case the order confirmation is not received within 15 days, it shall be presumed that the vendor has not accepted the order.

**Instructions for Bidders for Land Border sharing:**

**Clauses As per GOI, Ministry of Finance, Department of expenditure, Public Procurement Division Order (Public Procurement Order No.1) dated 23<sup>rd</sup> July 2020 for the Bidders**

- I. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.

- II. “Bidder” (including the term ‘tenderer’, ‘consultant’ or ‘service provider’ in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, Participating in a procurement process.
- III. “Bidder from a country which shares a land border with India” for the purpose of this Order means:-
- a. An entity incorporated, established or registered in such country; or
  - b. A subsidiary of an entity incorporated, established or registered in such a country; or
  - c. An entity substantially controlled through entities incorporated, established or registered in such a country; or
  - d. An entity whose beneficial owner is situated in such a country; or
  - e. An Indian (or other ) agent of such an entity; or
  - f. A natural person who is a citizen of such a country; or
  - g. A consortium or joint venture where any member of the consortium or joint venture falls under any of the above
- IV. The beneficial owner for the purpose of (iii) above will be as under:
1. In case of a company or Limited Liability Partnership, the beneficial owner is the natural person (s), who, whether acting alone or together , or through one or more juridical person, has a controlling ownership interest or who exercises control though other means.  
Explanation—
    - a. “Controlling ownership interest” means ownership of or entitlement to more than twenty-five per cent. Of shares or capital or profits of the company;
    - b. “Control shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreement or voting agreements.;
  2. In case of partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together , or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profit of the partnership;
  3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profit of such association or body of individuals;
  4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.
  5. In case of a trust, he identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or in ownership.
- V. An Agent is a person employed to do any for another, or to represent another in dealing with third person.
