- As per Govt. of India procurement policies, Purchase preference, eligibility of bidders and other conditions will be as prescribed in DIPP Order No. P- 45021/2/2017-PP (BE-II) dated 04.09.2020 and 16.09.2020 & subsequent DIPP order no. P- 45021/2/2017-PP (BE-II)-Part (4) Vol. II dated 08.07.2025 issued by DIPP. Bidders should mandatorily indicate whether they are under class I or class II local supplier or non-local suppliers.
- *“**Local supplier**” means a supplier or service provider whose product or service offered for procurement meets the minimum local content of 50% as prescribed in DIPP Order No. P-45021/2/2017-PP (BE-II) dated 4th June 2020 or by the competent Ministries/Departments in pursuance of this order.
- “**Local content**” means the amount of value added in India which shall, unless otherwise prescribed by the Nodal Ministry, be the total value of the items procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent
- The Director, CSIR-AMPRI, Bhopal, India reserves the right to accept any or all tenders either in part or in full or to split the order without assigning any reasons there for.

Note:

- The quotation should be submitted either by the principal manufacturer or authorized agent / dealer, both cannot bid simultaneously for the same item/product in the same tender. Bids of OEM would be considered in case both manufacturers and agent have quoted. If an agent has submitted the bid on behalf of the principal /OEM, the same agent shall not submit a bid on behalf of another principal/OEM in the same tender for the same item/product. One manufacturer can also authorize only one agent /dealer in a tender.
- Tender Document with Technical specifications is attached as PDF with additional documents in ATC. Prospective bidders are requested to submit the bids complying these technical specifications with supporting technical brochure and supporting documents must be uploaded with the technical bid. Technical comparison will be based on parameters mentioned in GeM bid and our technical specifications uploaded as PDF.
- Duly filled, seal and signed scanned copies of Annexures attached in the Tender document uploaded with ATC documents are mandatory to submit along with the technical bid. Technical bids not submitted with the said documents may be considered as non-responsive and may lead to rejection of the technical bids.
- No need to upload all tender documents with technical bid, please upload only relevant and required documents/ Annexures/ technical broacher.
- Non-comprehensive AMC prices needs to be filled in Annexure XV and should be submitted along with technical bid.
