- 04. Bids must be received through **etenders.gov.in**. No other mode is acceptable. Bids will be opened on the specified date and time. In the event of the date specified for bid opening being declared as a closed holiday for purchaser's office, the bids will be opened on next working day.
- 05. A Pre-bid Conference <u>Not Applicable</u>.
- 06. As per Govt. of India procurement policies, Purchase preference, eligibility of bidders and other conditions will be as prescribed in DIPP Order No. P-45021/2/2017-PP (BE-II) dated 16th September 2020. Bidders should mandatorily indicate whether they are under **class I** or **class II** local supplier. Non-local suppliers cannot participate in any of the tenders up to 200 crores.
 - # Local supplier means a supplier or service provider whose product or service offered for procurement meets the minimum local content as prescribed in DIPP Order No. 45021/2/2017-PP (BE-II) dated 16th September 2020 or by the competent Ministries / Departments in pursuance of this order.

"Local content " means the amount of value added in India which shall unless otherwise prescribed by the Nodal Ministry, be the total value of the items procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.

- NB: Govt. of India, Ministry of Commerce and Industry, Department for Promotion of Industry and Internal Trade (Public Procurement Section) vide OM No. P-45021/102/2019-PP(BE-II) (E-29930) dated 26.11.2020 confirmed on local content that bidders offering imported products will fall under the category of Non-local suppliers. They can't claim themselves as Class-I Local Supplier / Class-2 Local Supplier by claiming profit, warehousing, marketing, logistics, freight etc. as local value addition.
- 08. The Director, CSIR-AMPRI (Advanced Materials & Processes Research Institute, Bhopal reserves the right to accept or reject any bids or accept all tenders either in part or in full or to split the order, or to annul the bidding process without assigning any reason.
