Bidders should mandatorily indicate whether they are under class I or class II local supplier. Non-local suppliers cannot participate in any of the tenders up to 200 crores.
- *"Local supplier" means a supplier or service provider whose product or service offered for procurement 5. meets the minimum local content of 50% as prescribed in DIPP Order No.P-45021/2/2017-PP (BE-II) dated 4th June 2020 or by the competent Ministries/Departments in pursuance of this order.
- 'Local content' means the amount of value added in India which shall, unless otherwise prescribed by the 6. Nodal Ministry, be the total value of the items procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent
- 7. The Director, CSIR-AMPRI, Bhopal, India reserves the right to accept any or all tenders either in part or in full or to split the order without assigning any reasons there for.

Note: The quotation should be submitted either by the principal manufacturer or authorized agent / dealer, both cannot bid simultaneously for the same item/product in the same tender. Bids of OEM would be considered in case both manufacturers and agent have quoted. If an agent is submitted the bid on behalf of the principal /OEM, the same agent shall not submit a bid on behalf of another principal/OEM in the same tender for the same item/product on manufacturer can also authorize only one agent /dealer in a tender
