- 2. The Bid will be rejected if:

 - (ii) The Bid validity is shorter than the required period.
 - (iii) The tenderer has not agreed to some essential condition(s) incorporated in the tender enquiry.
- 3. The suppliers are required to furnish a certificate stating that the rates quoted are reasonable and standard and not higher than those charged to other Government Departments/ Public Sector Undertakings and other CSIR Laboratories. - 3. The tenderer should quote the rates of the items in figures as well as in words. In case of any disputes/ambiguity and the rates quoted in words/figures, the higher value quoted either of the two shall be considered.
- 4. The quotations shall be valid for a minimum period of 90 days from the date of opening of the tender.
- 5. Specific delivery period for supply at CSIR-AMPRI, Bhopal must be indicated. No extension for supply beyond due date will be granted.
- 6. The penalty shall be 0.5% per week towards late delivery & towards delay in installation & commissioning subject to the maximum of 10% of the total value of the Purchase order.
- 7. Unloading of material at AMPRI, Bhopal Stores has to be arranged by the firm.
