- 2. The Bid will be rejected if:
  - i. The Bid is unsigned and undated.
  - ii. The Bid validity is shorter than the required period.
  - iii. The tenderer has not agreed to some essential condition(s) incorporated in the tender enquiry.
- 3. <u>Payment: 100% payment on bill basis will be made through Wire Transfer only after satisfactory supply, of the Material at CSIR-AMPRI, Bhopal.</u>
- 4. The suppliers are required to furnish a certificate stating that the rates quoted are reasonable and standard and not higher than those charged to other Government Departments/ Public Sector Undertakings and other CSIR Laboratories.
