- 2. The Bid will be rejected if :
  - i. The Bid is unsigned and undated.
  - ii. The Bid validity is shorter than the required period.
  - iii. The tenderer has not agreed to some essential condition(s) incorporated in the tender enquiry.

# 3. <u>Payment: 100% payment on bill basis will be released through RTGS only after satisfactory supply, of the Material at CSIR-AMPRI, Bhopal.</u>

- 3.
