- 2. The Bid will be rejected if :

3. <u>Payment: 100% payment on bill basis will be released through RTGS only after satisfactory supply, of the Material at CSIR-AMPRI, Bhopal.</u>

- 3. The suppliers are required to furnish a certificate stating that the rates quoted are reasonable and standard and not higher than those charged to other Government Departments/ Public Sector Undertakings and other CSIR Laboratories. - 4. The tenderer should quote the rates of the items in figures as well as in words. In case of any disputes/ambiguity and the rates quoted in words/figures, the higher value quoted either of the two shall be considered.

- 6. Specific delivery period for supply at CSIR-AMPRI, Bhopal must be indicated. No extension for supply beyond due date will be granted.
